

- Social Security Card
 - (ORIGINAL to verify)
- CTHR Form Verified by IMS / Police District / OBI Staff

MISSION STATEMENT

Amass and gate keep accurate, complete and current information for agencies to utilize in the safeguard of life and property.

VISION STATEMENT

To create an enterprise or network on information reliable with real time, accurate, and shared connectivity of managed information.

We DO NOT process Juvenile History Checks. Juvenile information can be requested from your Juvenile District Court Presenting/Probation Representative.

We are not responsible for the number of years you are requesting. If you want to change the number after your CTHR is complete you will have to resubmit your documents and pay the \$15.90 fee again.

IMS will not fax documents for customers.

The Money Order stub is your receipt. We are not able to refund Money Orders after they have been processed.

Please send along a Self Addressed Stamped Envelope with your request to help IMS with both cost and time in sending out responses.

May take up to 4-6 weeks for completion.

POLICE REPORT REQUEST

REQUIREMENTS:

- Formal Request
 - Please include details of incident: log number, date, location, etc.
 - Vital information: date of birth, social security number, phone number.
- Valid State Driver's License or ID
 - (COPY)
- Release of Authorization if you are not an involved person on the report.
- Police Report (per page) \$2.12 Money Order - Will be determined on information found.
 - Payable to Navajo Nation

RELEASE OF AUTHORIZATION

A signed statement from you giving IMS permission to send your CTHR or Police Report to: Department, Mailing Address, Attention To, etc.

Please note that the original can only be sent to one address and not multiple, otherwise you have to pay an extra fee.
